Terms of Service

These Terms of Service ("Agreement") constitute a legal agreement between you ("User" or "you") and Setuup, a software development company ("Setuup," "we," or "us") regarding your use of the HLU SMS Broadcasting Service ("Service"). 3. Acceptable Use

- 3.1 Prohibited Activities: The Service must not be utilized for any illicit or nefarious purposes. You agree that the messages broadcasted through the Service will not contain any vulgar, racist, unlawful, threatening, abusive, libelous, defamatory, obscene, pornographic, profane, or otherwise objectionable content of any kind. You further agree not to transmit or broadcast any information that would constitute or encourage conduct that would violate national or international laws.
- 3.2 Compliance with Laws: You are solely responsible for ensuring that your use of the Service complies with all applicable laws and regulations. You agree not to use the Service in any way that would violate the laws of the Republic of Liberia or any other relevant jurisdiction.

4. Termination

- 4.1 Termination by Setuup: Setuup reserves the right to terminate or suspend your access to the Service, without notice, if we reasonably believe that you have violated any provision of this Agreement or if your use of the Service poses a risk to Setuup or any third party.
- 4.2 Account Blocking: In the event of a violation of these terms, conditions, and clauses, Setuup may, at its discretion, block or terminate your account without notice.

5.1 Changes to the Agreement: Setup may modify this Agreement at any time by posting the revised terms on the Setup website or through the Service itself. Your continued use of the Service after the effective date of the modified Agreement constitutes your acceptance of the modified terms.

- 7.2 Severability: If any provision of this Agreement is held to be invalid, illegal, or unenforceable, the validity, legality, or enforceability of the remaining provisions shall in no way be affected or impaired.
- 7.3 Waiver: The failure of Setuup to enforce any right or provision of this Agreement shall not be deemed a waiver of such right or provision unless acknowledged and agreed to in writing by Setuup.
- 7.4 Assignment: You may not assign or transfer any rights or obligations under this Agreement without the prior written consent of Setuup. Setuup may freely assign or transfer its rights and obligations under this Agreement.
- 7.5 Relationship of the Parties: Nothing in this Agreement shall be construed as creating a partnership, joint venture, agency, employment, or any other form of legal relationship between you and Setuup.
- 7.6 Survival: Sections 2, 3, 4, 5, 6, and 7 of this Agreement shall survive any termination or expiration of this Agreement.
